



CHC81115 GRADUATE DIPLOMA OF FAMILY DISPUTE RESOLUTION

The CH81115 Graduate Diploma of Family Dispute Resolution (FDR) is designed to prepare students for practice as a Family Dispute Resolution Practitioner (FDRP).

The qualification is based on current theory and practice and enables students to develop:

- **knowledge, skills and build competence for the practice of FDR under the Family Law Act (1975)**
- **an analytical reflective capacity as an FDRP.**

- FDR context and process
- Family violence
- Intake and assessment
- Family law and the obligations of FDRPs
- Children and parenting matters in FDR
- Property and financial matters in FDR
- Ethics and inclusive FDR practice

The role of an FDRP

FDRPs provide structured processes and facilitated negotiations for families about parenting, financial and property matters related to a separation process.

An FDRP's role includes providing information, undertaking intake and assessment around the suitability of the FDR process and capacity of families to participate, management of the FDR process and tailoring of it to individual needs.

Format

The CHC81115 Graduate Diploma of Family Dispute Resolution runs for one year over two semesters.

Semester one:

- Blended model with online learning modules, live and recorded webinars and blocked face-to-face skills workshops, and a field trip.

Semester two:

- a 50-hour work placement, where students will actively work with clients in a supervised environment
- five, half-day placement seminars which provide students with the opportunity to present and discuss cases.

Students also undertake additional reading and research in preparation for assessment tasks.

Intake

Course starts July 2023

Accreditation

Following successful completion of the Graduate Diploma, students will be qualified to:

- practice in the area of FDR
- apply for accreditation under the National Mediator Accreditation System (NMAS)
- register as an FDRP with the Australian Government's Attorney- General's Department.

Fees

\$13,390 (payable by instalment).

Entry requirements

To gain entry into the Graduate Diploma a candidate must have one of the following:

- an undergraduate degree or higher qualification in psychology, social work, law, conflict management, dispute resolution, family law mediation or equivalent, or
- accreditation under the National Mediator Accreditation System, or
- the mediation skill set from the Community Training Package, or
- ability to provide documented evidence of previous experience in a dispute resolution environment in a job role involving:
 - self-directed application of knowledge with substantial depth in some areas
 - exercise of independent judgement and decision-making
 - a range of technical and other skills

Recognition of Prior Learning

Recognition of Prior Learning (RPL) enables students to have their existing skills and knowledge relating to FDR acknowledged and status granted where appropriate.

This is available for people with extensive and relevant experience in family law, mediation, counselling or family and domestic violence.

To apply for RPL, you will need to provide evidence of the competencies needed for FDR by completing our RPL Application and Assessment Form, which we can provide on request. For more information, please refer to the [RTO Program Manual](#).

Semester two: work placement

- Students will participate in a minimum of 50 hours of client and case support work.

Unique Student Identifier

Students undertaking nationally accredited training will need to set up a Unique Student Identifier (USI) and provide this to RAV's administration team via email.

RAV is required to record and verify a USI for each student.
